Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016, revised November 2017 and August m2018 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.

The method of payment will be in cash or cashier's cheque or telegraphic transfer through MUDCo A/C No1000263128374 at Commercial Bank of Ethiopia (Swift Code CBETETAA). The document will be provided in hard copy to those bidders who come in person to purchase the bidding document and will also be sent by email with proof of receipt to all bidders who purchased the bidding document by transfer and provide proof of payment to the email address below.

6. Bids must be delivered to the address **below on or before 3.30 pm on Friday, December 18, 2020. Due to the COVID-19 pandemic, bidders have**, in addition to submission of hard copies, the option to submit their bids electronically by email and other options as specified in the Bidding Document. Late Bids will be rejected.
