The Future of Mobility has always been a futuristic concept of flying cars driven by robots. This concept was perceived not more than 3 decades and today in 2021 we are closer than ever to realize this dream. The only thing is Future of Mobility is much more than what we have mostly seen in sci-fi movies. The future of mobility is constantly transforming. From the Indian context, it has been a paradigm and pragmatic change in how India had earlier perceived mobility and how it is shaping up. The Metro trains in the Metros & the Tier-II cities had already started to define the mass transit. With Regional Rail Transit Systems, which will further complement intercity mass transit, advanced transit systems such as hyperloops, monorails and lite metro will make mass transit more popular and convenient. With cab aggregators coming in and gaining admiration since the beginning of the previous decade, has given a new dimension to daily commuters. Coupling with metro rails and alike, India has been fast catching up the way people travel in developed economies. Recently, with startups coming in the fields of selfdrive cars, long term car leasing and shuttle system for the last mile connectivity has further eased out the harrowing daily commute in cities, reducing congestions, pollution and need for parking spaces. COP 25 Agreement in 2015 has set up a new challenge for the country to fast change the mobility to Zero Emission.
