Selection will be conducted in accordance the African Union Procurement Manual and is open to all eligible applicants as defined in the Procurement Manual.

Applicants and all parties constituting the Applicant, shall meet the following criteria to be eligible for registration

- (a) the applicant has the legal capacity to enter into a contract;
- (b) the applicant is not:
  - (i) insolvent;
  - (ii) in receivership;
  - (iii) bankrupt; or
  - (iv) being wound up
- (c) the applicant's business activities have not been suspended by African Union, any International or Government Organizations.
- (d) the applicant is not the subject of legal proceedings for any of the circumstances in (b); and
- (e) the applicant has fulfilled his or her obligations to pay taxes

Applications must be sent by email on or before 12<sup>th</sup> December 2023, 14:00hrs CAT. The size of the attachment should not exceed 20MB. Late application will be automatically rejected. Applications will be publicly opened online on 12<sup>th</sup> December 2023, 14:30hrs CAT and the link for the opening will be shared on the ECOSOCC website (<u>https://ecosocc.au.int/</u>) for applicants' designated representatives and anyone who chooses to attend.
